7	WHEREAS, Provo City Code § 4.02.060 requires Provo City Department Directors to
8	reside within the municipal limits of Provo City; and
9	WHEREAS, the Provo City Administration has carefully reviewed this code requirement
10 11	and has prepared a memorandum analyzing the benefits and the disadvantages of requiring Provo
12	City Department Directors to reside within the geographic boundaries of Provo City; and
13	City Department Directors to reside within the geographic boundaries of 1 fovo City, and
14	WHEREAS, the review and the analysis by the Administration recommends elimination
15	of a Provo City Code residency requirement for department directors; and
16	or writers cray court restaurately requirement for separations street, and
17	WHEREAS, on March 6, 2012, March 20, 2012, and April 3, 2012, the Provo City
18	Municipal Council held duly noticed public meetings to ascertain the facts regarding the matter,
19	which facts are found in the meeting record; and

21	WHEREAS, after considering the administration's recommendations, and facts presented
22	to the Municipal Council, the Council finds elimination of the residency requirement for Provo
23	City Department Directors reasonably furthers the health, safety and general welfare of the
24	citizens of Provo City;

27	Utah, as follows:

31	Section 4.02.060 of the Provo City Code is hereby amended as follows:
32	4.02.060 Posidones Possuiroments

There shall be no residency requirement for employment with Provo City, except that a department director must reside in Provo City, and employees who have emergency response responsibilities shall be subject to reasonable regulations, established by the administration, controlling the distance they may reside from the location at which they perform their employment.
