

49 Section 2.01.050 of the Provo City Code is hereby amended as follows as illustrated in
50 the attached Exhibit "A":

52 **2.01.050. Council Districts.**

53 (1) The seven (7) members of the Municipal Council shall be elected to represent the
54 Council districts set forth below. ~~Changes or amendments to Council district boundaries made~~
55 ~~by ordinance do not affect the standing, constituency, or term of office of those duly elected~~
56 ~~Council members serving at the time of the change or amendment and a mid-term vacancy is not~~
57 ~~created solely through the effect of such a change or amendment.~~ A Council member who was
58 ~~duly elected to a previously existing Council district shall continue to represent the realigned~~
59 ~~district in which the Council member resides until the end of that Council member's term of~~
60 ~~office.~~

61 (a) COUNCIL DISTRICT 1: One (1) Council member shall be elected to
62 represent Council District 1 which includes the following voting precincts in Provo City,
63 or the successor(s) thereof: ~~8, 16, 29, 30, 32, 34, 41, 42 and 49~~ 15, 16, 26, 28, 29, 30, 32,
64 37, 38, 39, 40, 41, and 42. The representative of this district shall, when filing as a
65 candidate for office and at the time of election and while in office, be a resident of
66 Council District 1.

67 (b) COUNCIL DISTRICT 2: One (1) Council member shall be elected to
68 represent the Council District 2 which includes the following voting precincts in Provo
69 City, or the successor(s) thereof: ~~11, 26, 33, 36, 37, 39, 40, and 48~~ 8, 9, 11, 33, 34, and
70 36. The representative of this district shall, when filing as a candidate for office and at
71 the time of election and while in office, be a resident of Council District 2.

72 (c) COUNCIL DISTRICT 3: One (1) Council member shall be elected to
73 represent the Council District 3 which includes the following voting precincts in Provo
74 City, or the successor(s) thereof: ~~2, 3, 5, 9, 12, 17, 18, 35, 45, and 47~~ 1, 2, 3, 5, 12, 17, 44,
75 and 45. The representative of this district shall, when filing as a candidate for office and
76 at the time of election and while in office, be a resident of Council District 3.

77 (d) COUNCIL DISTRICT 4: One (1) Council member shall be elected to
78 represent the Council District 4 which includes the following voting precincts in Provo
79 City, or the successor(s) thereof: ~~10, 13, 19, 20, 23, 24, 25, 27, 28, 31, 38, and 46~~ 13, 18,
80 19, 20, 23, 24, 25, 27, 31, and 35. The representative of this district shall, when filing as
81 a candidate for office and at the time of election and while in office, be a resident of
82 Council District 4.

83 (e) COUNCIL DISTRICT 5: One (1) Council member shall be elected to
84 represent the Council District 5 which includes the following voting precincts in Provo
85 City, or the successor(s) thereof: ~~1, 4, 6, 7, 14, 15, 21, 22, 43, and 44~~ 4, 6, 7, 10, 14, 21,
86 22, and 43. The representative of this district shall, when filing as a candidate for office
87 and at the time of election and while in office, be a resident of Council District 5.

88 (f) CITY-WIDE DISTRICT I: One (1) Council member shall be elected to
89 represent City-wide District I which includes all of the voting precincts in Provo City.
90 The representative of this district shall, when filing as a candidate for office and at the
91 time of election and while in office, be a resident of Provo City.

92 (g) CITY-WIDE DISTRICT II: One (1) Council member shall be elected to
93 represent City-wide District II which includes all of the voting precincts in Provo City.
94 The representative of this district shall, when filing as a candidate for office and at the
95 time of election and while in office, be a resident of Provo City.

96 (2) The districts described in Subsection (1) shall govern any election or mid-term
97 vacancy occurring after July 17, 2012.

PART III:

A. If a provision of this Ordinance 2012-18 conflicts with a provision of a previously adopted ordinance concerning the same title, chapter, and/or section number amended herein, the provision in this ordinance shall prevail.

B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the ordinance shall not be affected thereby.

C. The Municipal Council hereby directs that the official copy of the Provo City Code be updated to reflect the provisions enacted by this ordinance.

D. This ordinance shall take effect immediately after being posted or published as required by law.
