(1) The compensation for the Mayor, who serves as the elected chief executive officer of the City, is set at eighty-nine thousand four hundred sixty-one dollars and thirty-five cents (\$89,461.35)one hundred nine thousand five hundred dollars (\$109,500.00) per annum.

## PART II:

A. If a provision of this Ordinance 2013-13 conflicts with a provision of a previously adopted ordinance concerning the same title, chapter, and/or section number amended herein, the provision in this ordinance shall prevail.

B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the ordinance shall not be affected thereby.

C. The Municipal Council hereby directs that the official copy of the Provo City Code be updated to reflect the provisions enacted by this ordinance.

D. This ordinance shall take effect immediately after being posted or published as required by law.
