118 A. If a provision of this ordinance conflicts with a provision of a previously adopted
119 ordinance, this ordinance shall prevail.

121 B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be
122 severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or
123 invalid, the remainder of the ordinance shall not be affected thereby.

125 C. The Municipal Council hereby directs that the official copy of the Provo City Code be
126 updated to reflect the provisions enacted by this ordinance.

128 D. This ordinance shall take effect immediately after being posted or published as required
129 by law.
