

46 It is hereby found and determined by the Municipal Council of ~~the~~ Provo City that for the
47 purpose of accepting gifts to ~~the~~ Provo City and for other related purposes, it is appropriate to the
48 general welfare, order and security of the City and in the best interests of its citizens that the City
49 create a nonprofit corporation under the provisions of the Utah Nonprofit Corporation and Co-
50 operative Association Act, Title 16, Chapter 6, Utah Code (subsequently replaced by Utah Code
51 Title 16, Chapter 6a – Utah Revised Nonprofit Corporations Act).

- 55 A. If a provision of this ordinance conflicts with a provision of a previously adopted
56 ordinance, this ordinance shall prevail.

- 58 B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be
59 severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or
60 invalid, the remainder of the ordinance shall not be affected thereby.

- 62 C. The Municipal Council hereby directs that the official copy of the Provo City Code be
63 updated to reflect the provisions enacted by this ordinance.

- 65 D. This ordinance shall take effect immediately after being posted or published as required
66 by law.
