48 A. If a provision of this ordinance conflicts with a provision of a previously adopted  
49 ordinance, this ordinance shall prevail.

51 B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be  
52 severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or  
53 invalid, the remainder of the ordinance shall not be affected thereby.

55 C. The Municipal Council hereby directs that the official copy of the Provo City Code be  
56 updated to reflect the provisions enacted by this ordinance.

58 D. This ordinance shall take effect immediately after it has been posted or published in  
59 accordance with Utah Code 10-3-711, presented to the Mayor in accordance with Utah  
60 Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713.
