(4) The sections in this 2016 edition are affected and superseded by any ordinance adopted by the Provo City Municipal Council after January 05, 2016.

PART II:

Provo City Code Section 1.01.020 is hereby amended as follows:

1.01.020 Citation.

This volume shall be known, and may be cited, as "Provo City Code, 2016 edition."

PART III:

 Provo City Code Section 4.04.050 is hereby amended to replace the 2014-15 Pay Range Table with the 2015-16 Pay Range Table attached hereto as Exhibit A. Based on the approval of these figures in the 2015-2016 Fiscal Year budget, this Pay Range Table is effective as of June 21, 2015.

PART IV

The Municipal Council hereby directs that formatting, grammatical, numbering, and similar errors be corrected and that the updated and corrected copy of the Provo City Code, including ordinances adopted on or before January 5, 2016 be adopted and published in book and electronic form as the 2016 version of Provo City Code.

PART V:

This ordinance shall take effect immediately after it has been posted or published in accordance with Utah Code 10-3-711, presented to the Mayor in accordance with Utah Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713.
