2 3 4 5	AN ORDINANCE AMENDING PROVO CITY CODE REGARDING MUNICIPAL COUNCIL MEMBERS' COMPENSATION. (17-071)
6 7 8 9	WHEREAS, under Provo City Code Section 4.04.125, the Elected Officials Compensation Commission (Compensation Commission) was created and tasked with recommending an annual salary for the Municipal Council members; and
10 11 12	WHEREAS, the average annual salary of city council members serving populations of greater than 85,000 is \$18,463; and
13 14 15 16	WHEREAS, the Compensation Commission concluded that these cities are most comparable to Provo in terms of population (greater than 85,000) and that salary for Provo City Council members should be in keeping with salaries for city council members in the area; and
17 18 19 20	WHEREAS, the Compensation Commission concluded that the duties of Provo Council members, and taking into consideration all the issues inherent in a city the size of Provo, warrant that Provo Council members salary be at least commensurate with similarly sized cities; and
20 21 22 23	WHEREAS, per City statute, a Compensation Commission is only convened to review the salary once every four years; and
24 25 26 27	WHEREAS, the Compensation Commission concluded that its recommendation will bring the Provo City Council members' salary up to a fair and equitable rate for the present day and the four years to follow; and
28 29 30	WHEREAS, the Compensation Commission recommends that the annual salary for Provo's City Council members be set at \$18,000; and
31 32 33 34	WHEREAS, on May 16, 2017, the Provo City Municipal Council held a duly noticed public hearing to ascertain the facts regarding this matter, which facts are found in the hearing record; and,
35 36 37	WHEREAS, all interested persons were given an opportunity to be heard at the public hearing; and
38 39 40 41	WHEREAS, after considering the proposed ordinance, and facts and comments presented to the Municipal Council, the Council finds that the ordinance, as set forth below, reasonably furthers the health, safety and general welfare of the citizens of Provo City.
42 43 44 45 46	NOW, THEREFORE, be it ordained by the Municipal Council of Provo City, Utah, as follows:

50	PART I.

52	Section 4.04.110 of the Provo City Code is hereby amended as follows:
53	
54	4.04.110. Municipal Council Members Compensation, Expenses and Benefits
55	(1) Each Municipal Council member shall be paid an annual salary of twelve thousand dollars
56	(\$12,000.00) eighteen thousand dollars (\$18,000).

59	PART II:

61	A. If a provision of this Ordinance conflicts with a provision of a previously adopted
62	ordinance concerning the same title, chapter, and/or section number amended herein, the
63	provision in this ordinance shall prevail.
64	
65	B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be
66	severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or
67	invalid, the remainder of the ordinance shall not be affected thereby.
68	
69	C. The Municipal Council hereby directs that the official copy of the Provo City Code be
70	updated to reflect the provisions enacted by this ordinance.

72	D. This ordinance shall take effect immediately after being posted or published as required
73	by law.
