47 1,800 linear feet of frontage directly adjacent to Interstate 15 shall be allowed one (1)

61 A. If a provision of this ordinance conflicts with a provision of a previously adopted  
62 ordinance, this ordinance shall prevail.

64 B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be  
65 severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or  
66 invalid, the remainder of the ordinance shall not be affected thereby.

68 C. The Municipal Council hereby directs that the official copy of the Provo City Code be  
69 updated to reflect the provisions enacted by this ordinance.

71 D. This ordinance shall take effect immediately after it has been posted or published in  
72 accordance with Utah Code 10-3-711, presented to the Mayor in accordance with Utah  
73 Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713.
