47 (4) At the Council meeting described above, the Council Chair shall receive nominations for the  
48 office of Council Chair and upon the close of the nominations, and without discussion, call for a  
49 vote. Each member of the Council will indicate the nominee for whom the Council member's  
50 vote is cast. The nominee receiving a majority vote of the Council will be declared elected. The  
51 election of the Vice-chair will then be held by the process described above.

52  
53 (5) The newly elected Municipal Council Chair and Vice-chair shall take office immediately at  
54 the end of the election and remain in office until the succeeding Council Chair and Vice-chair are  
55 elected.

57 (6) The Council Chair shall occupy the center seat and the Vice-chair shall occupy the seat on  
58 the Council Chair's left.

62 Provo City Code Section 2.50.035 is hereby amended as follows:

64 **2.50.035. Regular Council Meetings.**

65 The Municipal Council shall hold regular meetings on ~~the first and third~~ select Tuesdays ~~of each~~  
66 ~~month~~ at 5:30 p.m. except as may be otherwise provided by law, ~~or as set~~ The Council shall adopt  
67 for each year ~~may direct~~ by resolution a calendar of the dates on which these regular meetings  
68 will be held and shall published the calendar as provided in Utah Code Section 52-4-202(2),  
69 ~~Utah Code~~, as amended. The calendar of regular meetings may be amended by resolution as  
70 needed. Public notice of any Municipal Council meeting shall be given as provided in  
71 Section 52-4-202, Utah Code, as amended.

74 PART III:

76 A. If a provision of this ordinance conflicts with a provision of a previously adopted  
77 ordinance, this ordinance shall prevail.  
78  
79 B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be  
80 severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or  
81 invalid, the remainder of the ordinance shall not be affected thereby.  
82  
83 C. The Municipal Council hereby directs that the official copy of the Provo City Code be  
84 updated to reflect the provisions enacted by this ordinance.

86 D. This ordinance shall take effect immediately after it has been posted or published in  
87 accordance with Utah Code 10-3-711, presented to the Mayor in accordance with Utah  
88 Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713.
