

3 AN ORDINANCE AMENDING PROVO CITY CODE REGARDING THE
4 RECODIFICATION OF PROVO CITY CODE. (18-033)

6 WHEREAS, it is proposed that Provo City Code Chapter 1.01 (Recodification of Provo
7 City Code) be amended to reflect that Provo City Code (the Code) is now updated as ordinances
8 are approved rather than on an annual basis;
9

10 WHEREAS, in the past, the Code was updated and republished annually in a hard copy
11 format; and
12

13 WHEREAS, the current version of the Code is now maintained electronically and is
14 updated as new ordinances are approved; and
15

16 WHEREAS, on March 6, 2018 and March 27, 2018, the Municipal Council met to
17 ascertain the facts regarding this matter and receive public comment, which facts and comments
18 are found in the public record of the Council’s consideration; and
19

20 WHEREAS, after considering the facts and comments presented to the Municipal
21 Council, the Council finds (i) Provo City Code Chapter 1.01 (Recodification of the Provo City
22 Code) should be amended as set forth below, and (ii) this action reasonably furthers the health,
23 safety, and general welfare of the citizens of Provo City.

25 NOW, THEREFORE, be it ordained by the Municipal Council of Provo City, Utah, as

30 Provo City Code Chapter 1.01 (Recodification of Provo City Code) is hereby amended as
31 set forth below.

37 (1) This ~~2016 edition~~ **volume** is a compilation of codified municipal ordinances, entitled "Provo City Code, ~~2016~~
38 ~~edition,~~" and is adopted by Provo City, Utah, pursuant to the provisions of Utah Code Title [10](#), Chapter [3](#), Part
39 7.

40 (2) This ~~2016 edition~~ **volume** supersedes any previously **published volume of** codified ordinances.

41 (3) This ~~2016 edition~~ volume shall not supersede any uncodified ordinance of a private, local, or temporary
42 nature, including, but not limited to, ordinances authorizing the execution and issuance of deeds, bonds, or
43 contracts, the creation of special improvement districts, the amendment of zoning maps, and the vacation of
44 streets.

45 (4) The sections in this ~~2016 edition~~ volume are affected and superseded by any ordinance adopted by the
46 Provo City Municipal Council after the date of publication shown herein. Any such ordinance shall be effective
47 as provided by the text of the ordinance itself, or by state law if no effective date is stated in the ordinance,
48 regardless of when they may appear in compiled form in this volume. A printed edition of this volume is
49 updated and made available on an annual basis. An electronic edition is available online and is updated as
50 new ordinances are approved. ~~after January 5, 2016.~~

52 This volume shall be known and may be cited as "Provo City Code, ~~2016 edition.~~"

- 57 A. If a provision of this ordinance conflicts with a provision of a previously adopted
58 ordinance, this ordinance shall prevail.

- 60 B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be
61 severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or
62 invalid, the remainder of the ordinance shall not be affected thereby.

- 64 C. The Municipal Council hereby directs that the official copy of the Provo City Code be
65 updated to reflect the provisions enacted by this ordinance.

- 67 D. This ordinance shall take effect immediately after it has been posted or published in
68 accordance with Utah Code 10-3-711, presented to the Mayor in accordance with Utah
69 Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713.
