52 A. If a provision of this ordinance conflicts with a provision of a previously adopted
53 ordinance, this ordinance shall prevail.

55 B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be
56 severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or
57 invalid, the remainder of the ordinance shall not be affected thereby.

59 C. The Municipal Council hereby directs that the official copy of the Provo City Code be
60 updated to reflect the provisions enacted by this ordinance.

62 D. This ordinance shall take effect immediately after it has been posted or published in
63 accordance with Utah Code 10-3-711, presented to the Mayor in accordance with Utah
64 Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713.
