

47 Subsection (1)(a). The Chairs of the Downtown Neighborhood shall each have all of the
48 responsibilities and duties of a Neighborhood Chair described in this Chapter.

50 (c) Except for the Downtown and East Bay Neighborhoods, Each Neighborhood, in a
51 meeting held under the direction of the Municipal Council Executive Director, shall
52 allow owners of the businesses located within the Neighborhood to elect a representative
53 who shall serve as the Business Liaison to represent their interests at Neighborhood
54 meetings and in presentations to the Municipal Council. Business Liaisons shall not be
55 eligible to fill in for the Neighborhood Chair in matters representing the voice of the
56 Neighborhood residents.

58 PART II:

60 A. If a provision of this ordinance conflicts with a provision of a previously adopted
61 ordinance, this ordinance shall prevail.

63 B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be
64 severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or
65 invalid, the remainder of the ordinance shall not be affected thereby.

67 C. The Municipal Council hereby directs that the official copy of the Provo City Code be
68 updated to reflect the provisions enacted by this ordinance.

70 D. This ordinance shall take effect immediately after it has been posted or published in
71 accordance with Utah Code 10-3-711, presented to the Mayor in accordance with Utah
72 Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713.
