48 Section 2.50.130 of the Provo City Code is hereby amended as follows:

49 **2.50.130. Executive Director for the Municipal Council - Assignment of Duties.**

51 (2) The Executive Director’s powers and duties may include, but are not limited to, the  
52 following:

54 ~~(k) Supervise Council employees, including conducting performance evaluations and pay  
55 adjustments as prescribed by Council policy and coordinating and providing appropriate training;~~

56 (k) Supervise Council employees and agents, administering and exercising all appropriate  
57 supervisory powers including, but not limited to, hiring, training, conducting performance  
58 evaluations and administrative pay adjustments, disciplining, and terminating, as are necessary  
59 for the proper administration and effective operation of the Council Office.

64 A. If a provision of this ordinance conflicts with a provision of a previously adopted  
65 ordinance, this ordinance shall prevail.

67 B. This ordinance and its various sections, clauses and paragraphs are hereby declared to be  
68 severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or  
69 invalid, the remainder of the ordinance shall not be affected thereby.

71 C. The Municipal Council hereby directs that the official copy of the Provo City Code be  
72 updated to reflect the provisions enacted by this ordinance.

74 D. This ordinance shall take effect immediately after it has been posted or published in  
75 accordance with Utah Code 10-3-711, presented to the Mayor in accordance with Utah  
76 Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713.
