Parking Design Standards.

- (15) Parking located adjacent to walls or columns (e.g., parking structures) shall must be one (1) foot wider to accommodate door opening clearance and vehicle maneuverability. Parking located adjacent to columns (e.g., parking structures) also must be one (1) foot wider except for columns placed within four (4) feet of the front or back of a stall. Parking located in a corner adjacent to a parking row must be two (2) feet wider. The stall width shall must be clear width measured from inside column to inside column. The backup area in carports and parking structures shall must be twenty-six (26) feet minimum from supporting column to supporting column. Parking spaces must be free of obstructions. The Development Services director may reduce the requirements of this Subsection based upon a finding that
 - (a) individual circumstances make meeting the standard infeasible or unreasonable; and
 - (b) the reduction does not create a health or safety hazard.
