ORDINANCE 2023-8

AN ORDINANCE AMENDING THE LIST OF APPENDICES INCLUDED IN
THE PROVO CITY GENERAL PLAN. CITYWIDE APPLICATION.
(RELATED TO PLGPA20210364)

WHEREAS, on January 17, 2023, the Provo Municipal Council adopted an ordinance completely amending, revising, and updating the Provo City General Plan; and

WHEREAS, the ordinance adopted on January 17, 2023, for the Provo City General Plan included an amended, revised, and updated list of appendices; and

WHEREAS, after adoption of said ordinance, the list of appendices was found needing additional revisions. The Development Services Department staff prepared an amended, updated, and revised list of appendices for the General Plan; and

WHEREAS, on March 8, 2023, the Planning Commission held a duly noticed public hearing to consider a proposed amendment to amend, update, and revise the list of appendices included in the General Plan, and after such meeting, the Planning Commission recommended approval to the Municipal Council by a vote of 7-0; and

WHEREAS, on March 28, 2023, the Municipal Council met to ascertain the facts regarding this matter and receive public comment, which facts and comments are found in the public record of the Council's consideration; and

WHEREAS, after considering the Planning Commission's recommendation and facts and comments presented to the Municipal Council, the Council finds (i) the list of appendices for the Provo City General Plan should be amended, revised, and updated as described herein and (ii) the proposed amendment, revisions, and updates reasonably furthers the health, safety and general welfare of the citizens of Provo City.

NOW, THEREFORE, be it ordained by the Municipal Council of Provo City, Utah, as follows:

PART I:

The amended, revised, and updated list of appendices for the Provo City General Plan is hereby adopted as set forth in Exhibit A and B. Any appendix listed in Exhibit A that was not previously a part of the General Plan is hereby added in its entirety. Any appendix stricken from the list in Exhibit A is hereby repealed and deleted from the General Plan.

PART II:

- A. If a provision of this ordinance conflicts with a provision of a previously adopted ordinance, this ordinance shall prevail.

47 B. This ordinance and its various sections, clauses and paragraphs are hereby
48 declared to be severable. If any part, sentence, clause or phrase is adjudged to be
49 unconstitutional or invalid, the remainder of the ordinance shall not be affected
50 thereby.

52 C. The Municipal Council hereby directs that the official copy of the Provo City
53 Code be updated to reflect the provisions enacted by this ordinance.

55 D. This ordinance shall take effect immediately after it has been posted or published
56 in accordance with Utah Code 10-3-711, presented to the Mayor in accordance with
57 Utah Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713.
