Β. This ordinance and its various sections, clauses and paragraphs are hereby 47 declared to be severable. If any part, sentence, clause or phrase is adjudged to be 48 unconstitutional or invalid, the remainder of the ordinance shall not be affected 49 50 thereby. 51 С.
